PIMCO Unconstrained Bond Fund (Canada) takes a flexible approach to capturing global opportunities and managing risk. It strives to actively mitigate downside risk, provide attractive risk-adjusted returns and preserve the diversification benefits of a traditional fixed income portfolio.

- **Tactically allocated across a global opportunity set** by removing benchmark constraints, the fund gains significant latitude to tap into credit, interest rate, volatility and currency opportunities across global sectors and regions.
- **Absolute return focus** The fund's defensive capabilities and wide duration range (-3 to +8 years) help it to enhance returns across a wide range of market environments.
- **A unique portfolio complement** The fund seeks to provide many of the benefits associated with core bond funds - such as capital preservation, liquidity and diversification. At the same time, it aims to deliver returns materially above cash over full market cycles.

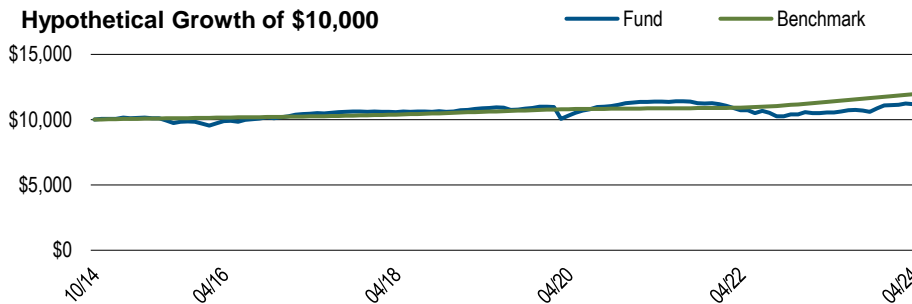

Duration is a measure of a portfolio's price sensitivity expressed in years.

The **Sharpe Ratio** measures the risk-adjusted performance. The risk-free rate is subtracted from the rate of return for a portfolio and the result is divided by the standard deviation of the portfolio returns.

Volatility is measured by the standard deviation, or dispersion of a set of data from its mean, based on historical portfolio returns. A larger spread of data indicates higher standard deviation and higher volatility.

Effective maturity is a weighted average of all the maturities of the bonds in a portfolio, computed by weighting each bond's effective maturity by the market value of the security.

Canadian Overnight Repo Rate (CORRA) measures the cost of overnight general collateral funding in Canadian dollars using Government of Canada treasury bills and bonds as collateral for repurchase transactions.
